

Terms of Use and Privacy Policy

1. Purpose of this Website

The Enfield NH Zoning Feedback Portal is an independent website intended to educate the public, facilitate discussion, and gather community feedback regarding zoning-related topics in Enfield, New Hampshire.

This website is **not** operated by or affiliated with the Town of Enfield or any town board, committee, or official.

Participation on this website is **not** a substitute for participating in the official public process. If you wish to influence a zoning decision, you should also attend public meetings, submit comments directly to the Planning Board, or use other official methods established by the Town.

2. Accounts

You are responsible for maintaining the accuracy of your account information and for activity occurring under your account.

You may not impersonate another person or create accounts using false or misleading information.

The website reserves the right to suspend or terminate accounts that violate these Terms.

3. Discussion Rules

This website is intended for discussion of zoning policy and related issues. Discussion should focus on proposals, regulations, and ideas—not on individual people.

Posts must remain relevant to the topic being discussed, contribute constructively, and remain respectful and civil.

The following content is prohibited: discussion of individual people, including personal praise or criticism, personal attacks, harassment, threats, or intimidation, discriminatory or hateful content, knowingly false or misleading factual statements, spam or commercial promotion, duplicate or repetitive submissions, illegal content, content unrelated to the discussion topic. All discussion submissions are subject to moderation before publication. The website may approve, reject, edit formatting, or remove submissions that violate these Terms. Moderation decisions are final.

4. Poll Participation

Some polls may be limited to users who satisfy eligibility requirements established by the website.

If you choose to provide your legal name and Enfield street, that information will be used solely to verify your eligibility to participate in community polls.

Providing false information for the purpose of participating in polls may result in votes being removed and your account being suspended or terminated.

5. Submitted Content

By submitting comments or other content to this website, you grant the website a permanent, irrevocable, royalty-free right to use, reproduce, modify, summarize, publish, archive, and distribute that content in connection with the operation of the website and reports or summaries prepared from community feedback.

Discussion comments are displayed anonymously. Submitted content may be associated with your account for moderation and administration purposes but will not be publicly attributed to you.

Submitted content may not be edited or removed at your request after submission.

6. Privacy

The website collects only the information reasonably necessary to operate its services.

Email addresses are used only for account authentication, account-related communications, discussion moderation, and optional website notifications. If optional notification emails are offered, you will be able to unsubscribe from future notification emails.

Legal names and Enfield streets are used only to determine eligibility for participation in community polls.

The website does not sell personal information or voluntarily disclose it to third parties except as required by law.

7. Disclaimer

Information provided on this website is offered for informational purposes only and is provided "as is" without any warranty of accuracy, completeness, or availability.

Although reasonable efforts are made to keep information current and accurate, users should verify important information through official Town sources before relying upon it.

The website may be modified, suspended, or discontinued at any time without notice.

To the maximum extent permitted by law, the website owner shall not be liable for damages arising from the use of, or inability to use, this website or its content.
